HERDSMANSHIP DAILY AWARD (Jeanne) – Jeane found a banner at a lesser cost than a rosette. A picture of the banner was passed around and discussed.

Kaieligh motions to purchase a 12x18 banner in green and white that has the 4-H clover and says, "Herdsmanship Daily Award, Clark County Fair". Cindy seconds the motion. MOTION PASSED/APPROVED

EDUCATIONAL DISPLAY – Tricia is coordinating this event and has created a volunteer list that includes times for clubs to volunteer. If your club is able to volunteer during the listed time, please do so.

Discussion was had about having those on herdsmanship being able to volunteer at the educational display. This interactive display includes hands-on activities such as putting a halter on, how to braid, how to put a leg wrap on and others. It was discussed that members could, after ensuring horses are watered and stalls cleaned and aisles taken care of, go to a scheduled volunteer shift at the educational display area. It is hoped that members will fill these volunteer shifts.

UPDATE AFTER MEETING (not discussed at meeting) – The shifts for the educational display are OPTIONAL. It will be an opportunity for the members to volunteer and take a break from herdsmanship if they would like. The volunteer list created by Tricia gives each club equal opportunity to participate if they want, but it is not mandatory to fill those shifts. Members can choose to volunteer for the whole hour or a portion of the hour.

ADDING SMALL EQUINE DRESSAGE (Jeanne) – We can add Small Equine Dressage to fair. It has been added to the Last Chance show. It is not on the CCF entry form, but Jeanne and/or Ann will reach out to those who have signed up for Small Equine to see if they want to enter this class.
