- c. RECORD BOOKS – Tricia Goode will look into ways to improve the record book for the 2024/2025 4-H year
- c. DEADLINES/DUE DATES FOR FAIR –
 - May 1 is last day to sign up;
 - May 1 Horse Certificates
 - Fair Entry forms due last day of June
 - When submitting stall requests, remember to put in special requests
 - Club EOY and new year paperwork due December 1
 - ALL leaders must attend a 4-H Kick-off meeting
 - Returning members must be signed up by end of December – REMEMBER 4-H members are NOT 4-H members until enrolled and therefore not covered under WSU/4-H insurance until enrolled.
- d. RANGE RIDERS use of TRAIL EQUIPMENT for 4-H open rides (Cori) – Range Riders would like to start holding 4-H open rides when the fairgrounds can be arranged and has requested to use the county 4-H trail equipment during these rides.
 - Lori motions to allow the county 4-H trail equipment to be used for 4-H open rides at the fair grounds/Kaileigh seconds – ALL APPROVED/MOTION PASSED to use county trail equipment for 4-H open rides at the Clark County Fairgrounds
 - FIRST 4-H Open Ride scheduled for Thursday March 21 6 – 8 p.m. (haul-in at 5:30 p.m.) \$10/per rider
- e. NEW SHOWMANSHIP PATTERNS (Kaileigh) – Kaileigh will have new patterns to submit by the new year or end of January at the latest.
- f. CONTAINER (update from Missy) – Fair is asking for a written agreement/contract between WSU/4-H and fair grounds for liability purposes. This agreement is in the process. The new container cannot be delivered until the agreement is agreed to and executed. Once the container arrives, it is likely that the equipment will be moved during one of the pre-fair shows when there will be plenty of help.
- g. DONATED SADDLE (Stacy) – A saddle was donated to the 4-H Horse Leaders years ago (unknown by who or exactly when). Cori will take the saddle as she has many new and young members. If she cannot find someone to use it she will sell and donate money back to 4-H Horse Leader Association.
