c. Horse Superintendent's report (Jeanne/Ann)

The following discussions/requests have been had/made:

CLOSING STALL AISLES: It has been requested by 4-H Horse superintendents to close stall aisles during decoration and decoration tear-down day at fair.

PARENT HELPER BADGES: Parent Helper Badges are coming back! It is likely that each club will receive 2 badges - 1 Parent Helper Badge for the barn (to help members in the barn) and 1 Parent Helper Badge for the arena (a parent to help ALL members with tack, patterns, etc.). Leaders must make clear to their parents that by taking the responsibility of wearing this badge means that assistance must be provided to ALL members, not just their own child.

2023 SCHEDULE AND START TIMES: At this time, the schedule and start times will remain the same as 2022, but this will be confirmed once we know how many are participating and in what events at the 2023 CCF.

WALK/TROT CLASSES: It has been requested and likely approved that walk/trot classes will be offered at fair. This is for members who are no longer eligible to enter novice classes (2 years max) but who are not yet ready to enter into the all gait classes.

GAME SHOWS: Mamie has 2 dates that she will be requesting use of the Clark County Saddle Club - March 19 and June 11. Confirmation of gaming dates to come.

b. Fundraising Committee (Lori)

SETTING FUNDRAISING GOAL: Lori suggests calculating the yearly costs of what it will take to put on the pre-fair shows for the year and then deduct an amount reasonable to assume will be from entry fees in order to determine a “set goal” for fundraising each year.
